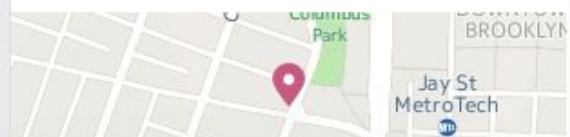

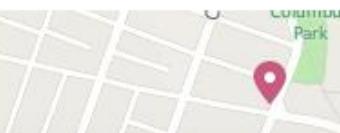

SEO: Search Engine Optimization

- Different ways to enhance your search engine results
 - Hire an SEO specialist/team or work with a dedicated SEO agency
- **Monthly retainer:** set fee each month for certain services you agree on, most common choice, greatest ROI
- **Contract services:** fixed prices for certain services like a website audit
- **Project-based pricing:** custom projects based on needs with fees similar to contract services
- **Hourly consulting:** Consultation about information and services with hourly pricing
- **Price:** Range from \$0.15/word, \$100/hour, \$500/service, \$700/month

SEO: Our Suggestion
